THE ABILITY EXPERIENCE MUCH TO CELEBRATE IN 2019 THANKS TO THE INCREDIBLE SUPPORT OF MORE THAN 9,000 DONORS. WE CONSISTENTLY GREW THE NUMBER OF SHARED EXPERIENCES BETWEEN MEN OF PI KAPPA PHI AND PEOPLE WITH DISABILITIES AND LOCALIZED OUR MISSION. THE NUMBER OF VOLUNTEER PARTNERSHIPS WE HAD ON CAMPUSES ACROSS THE COUNTRY ROSE FROM 105 TO 126 WHICH WAS 17% INCREASE FROM LAST YEAR. THROUGH THESE VOLUNTEER PARTNERSHIPS MORE THAN 4,500 STUDENTS ENGAGED WITH PEOPLE WITH DISABILITIES ON CAMPUSES ACROSS THE COUNTRY.

WE ALSO INCREASED THE NUMBER OF OUR STUDENT MEMBERS WORKING DIRECTLY WITH PEOPLE WITH DISABILITIES. WE SENT TWO TEAMS TO GUATEMALA IN THE SPRING AND DOUBLED THE IMPACT IN SANTIAGO ATITLN. THE TWO TEAMS BUILT ACCESSIBLE AMENITIES FOR ADISA AND EDUCACIN ESPECIAL.

ABILITY CAMPS IN THE UNITED STATES SAW A JUMP AS WELL THIS PAST YEAR. WE HOSTED 21 CAMPS WITH 728 PARTICIPANTS. AT EACH CAMP STUDENTS WORKED HARD TO BUILD AND RENOVATE STRUCTURES, SAVING OUR PARTNERS AN ESTIMATED \$244,712 OVER 9,412 MAN HOURS.

THE ABILITY EXPERIENCE ALSO AWARDED \$37,500 IN GRANTS TO 49 ORGANIZATIONS THROUGH ITS CYCLING EVENTS AND ANOTHER \$30,000 TO CAMPS THROUGH BUILD AMERICA.
